

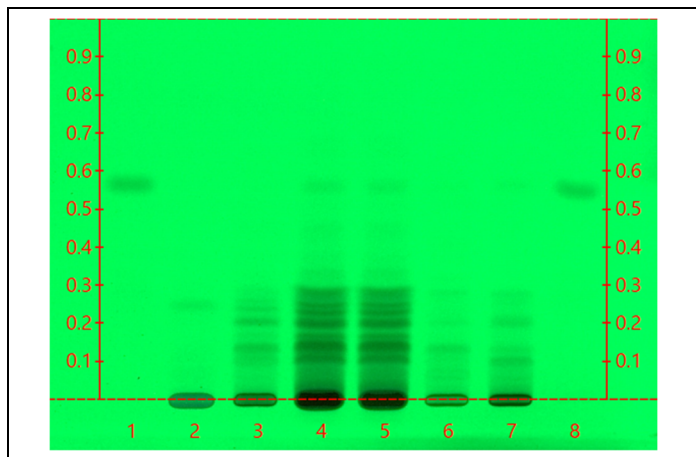

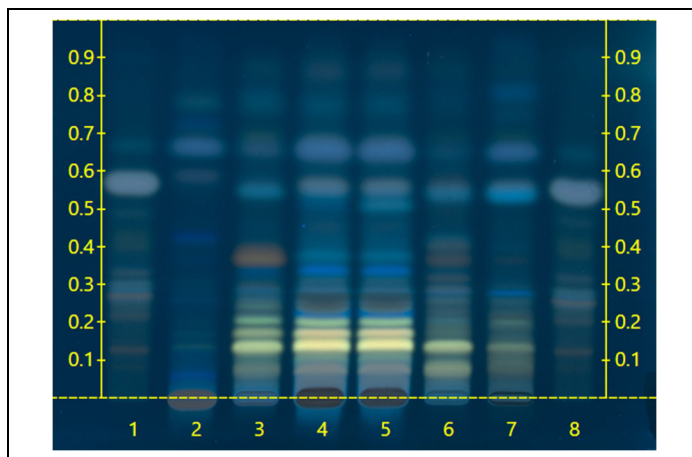

Comments & Conclusions: Lanes 4, 5 are the test sample REISHI (BREIS24OCT22). Lanes 2, 3, 6, 7, are the reference samples used for comparison. This test sample, REISHI (BREIS24OCT22) is consistent with the chromatographic profile of the reference samples of *Ganoderma lucidum* s.l., used above. **This test sample REISHI (BREIS24OCT22) has characteristics of a customized extract derived from *Ganoderma lucidum* s.l. fruiting body.**

NOTE: The above conclusion may be a function of the natural variance found in botanicals &/or the extraction process used to create specific extracts. The growing and drying conditions, age, seasonal variations, geographic location, extraction solvents, etc. all play a role in the phytochemical fingerprint of botanicals as well as their extracts; hence, chromatographic variations are expected.
